4. FIRST AID MEASURES

5. FIRE-FIGHTING MEASURES

Extinguishing media

: Recommended: alcohol-resistant foam, CO_2 , powders, water spray.

6. ACCIDENTAL RELEASE MEASURES

Personal precautions

: Exclude sources of ignition and ventilate the area. Avoid breathing vapor or mist. Refer to protective measures listed in sections 7 and 8.

Spill

: Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see section 13). 7. HANDLING AND STORAGE

Handling

: Vapors are heavier than air and may spread along floors. Vapors may form explosive mixtures with air. Prevent the creation of flammable or explosive concentrations of vapors in air and avoid vapor concentrations higher than the occupational exposure limits.

In addition, the product should only be used in areas from which all naked lights and other sources of ignition have been excluded. Electrical equipment should be protected to the appropriate standard.

Keep container tightly closed. Keep away from heat, sparks and flame. No sparking tools should be used.

Hygiene measures

11. TOXICOLOGICAL INFORMATION

Exposure to component solvent vapor concentrations in excess of the stated occupational exposure limit may result in adverse health effects such as mucous membrane and respiratory system irritation and adverse effects on the kidneys, liver and central nervous system.
